INSTRUCTIONS

Membership Fees

1. The Membership Fee for 2025-2026 is \$55.00. This covers membership for two people – the applicant and a nominated family member.
2. Membership renewals are due by 30 June 2025. For RCCSA Club Registration to be maintained, owners must be financial members on or before this date. If you allow your membership to lapse, so becoming unfinancial then your club registered vehicle will be unregistered and uninsured.
3. If you want a new Club Badge(s) or a replacement badge(s) then there is an additional cost of \$16.00 per badge. If required, please write the name required for each badge.
4. If you require a new logbook(s) at \$5.00 per book please calculate the number required and include with your payment.
