### Membership Fees

1. The Membership Fee for 2026-2027 is \$60.00. This covers membership for two people – the applicant and a nominated family member for a period of twelve months. A pro-rata reduction may apply if close to membership renewal time.
2. There is currently no joining fee but if you want a Club Badge(s) then there is an additional cost of \$16.00 per badge. If required, please write the name required for each badge. It is recommended that new members purchase badges.
3. Membership renewals are due by 30 June each year. For RCCSA Vehicle Registration to be maintained, owners must be financial members on or before this date. If you allow your membership to lapse, so becoming unfinancial then your club registered vehicle will be unregistered and uninsured.
4. If you require a Historic Registration Logbook(s) at \$5.00 per book (one per vehicle on conditional registration) please calculate the number required and include with your payment.
